A small charity like CHIT can keep things personal, keep in touch with its supporters, and keep expenses to the absolute minimum. All the money you give goes to India: the office is run by volunteers. Effective governance is achieved through an annual visit by one or more CHIT Trustees, sometimes accompanied by benefactors, staying in the Bapatla Home and working closely with the Indian Management and Indian Trustees.
